

# **DERRY TOWNSHIP BOARD OF SUPERVISORS**

## **Minutes, April 6, 2010 Regular Meeting**

**7:00 p.m.**

Chairman Vincent DeCario called the regular meeting of the Derry Township Supervisors to order in the Municipal Building at 5321 Route 982, Derry, PA at 7:00 p.m. and lead the group with the Pledge of Allegiance.

Motion was made by Daniel Rullo and seconded by David Slifka to adjourn the previous meeting.

Announcements: The 2010 Census Form has been mailed to residents. The Supervisors urge all residents to complete and return the form. A U.S. Census representative will be located in the Municipal Building until April 19<sup>th</sup> to answer any questions that residents may on Mondays, Wednesdays, and Fridays from 8 a.m. to 11 a.m.

Burning Days: Tuesday-Thursday-Saturday (10 a.m. to 5 p.m.)

Residents can not burn on the ground-must burn in a barrel, elevated one foot off the ground with a cover so the ashes do not blow.

Junk Vehicles: Vehicles without current inspection or license are considered junk and must be removed from the property. Residents may call the office if they wish to file a complaint.

Westmoreland Cleanways is having a spring recycling "hard-to-recycle" stuff collection at the Westmoreland County Fairgrounds on Saturday, April 10<sup>th</sup> from 8:30 to Noon.
