The Supervisors are again asking residents to stop placing their recyclable materials at the newspaper bins over the weekends. Residents can only bring their recyclables to the Municipal Building during business hours.

The meeting was open to the public for comments: Irene Cinibulk complained about the garbage man driving the truck up her alley, shrubs not getting trimmed along Foggy Way causing a site problem, a junk yard down by the honor roll, the sewage smell from the sewage plant, the smell of people burning garbage, and if separate taps are required for houses and mobile homes or if one tap is permitted. A discussion was held. Miss Cinibulk was referred to the Derry Township Municipal Authority for any public sewage questions.

Dale Jones of 4718 Park Drive, Richmond, Virginia, who owns property in Derry Township questioned issuing building permits where there are not adequate right-of-ways for emergency vehicles to enter in the interest of public safety. He requested an ordinance be adopted.

Judy Knopsnider complained about a box truck blocking the site distance at the intersection of Valley Street and State Route 217. Terry Giannini, Code Enforcement Officer, stated he would have the truck moved.

Len Butala questioned if the grass was mowed on St. Clair Street. Terry Giannini stated that the grass was cut last week. The property was up for sheriff sale and until the Bank purchases the property nothing can be done because there is no owner. That is why it takes so long.
