

DERRY TOWNSHIP BOARD OF SUPERVISORS

Minutes, February 2, 2010 Regular Meeting

7:00 p.m.

Chairman Vincent DeCario called the regular meeting of the Derry Township Supervisors to order in the Municipal Building at 5321 Route 982, Derry, PA at 7:00 p.m. and lead the group with the Pledge of Allegiance.

Motion was made by David Slifka and seconded by Daniel Rullo to adjourn the previous meeting.

Members present were: Vincent DeCario, David Slifka, and Daniel Rullo-Supervisors; Terry Giannini, Code Enforcement Officer and John Rushford, Solicitor.

Announcements: Reminder to recycle your newspapers, catalogs, and magazines in the green and yellow containers in the parking lot. The Township is paid per ton by Abitibi-Consolidated Corporation

On weekends people are dropping off their recycling-glass, cans, and plastic-in plastic bags. The containers are located inside the gate and is open during business hours. The Township has to pay \$250 each time the container is emptied. These containers are only available to Derry Township Residents.

Regarding snow removal-residents are asked to keep their vehicles off the road right-of-ways in an effort to help the drivers remove the snow as best as possible.

The meeting was opened to the public for comments: Lenny Butala questioned the minutes for January, page 3 the advertising of the meetings for 2009 should be 2010. The Supervisors agreed and will make the necessary change.

Irene Cinibulk asked the supervisors to repair a pothole at the intersection of Main Street and Industrial Boulevard. Supervisor David Slifka stated he would fix the pothole as soon as possible. She also questioned why the sewerage authority was placing a lien on the property owners who do not pay their sewerage or tap-in fee instead of shutting their water off. She was directed to address this issue with the Derry Township Municipal Authority who meets the last Wednesday of each month.

Irene Cinibulk requested a tree at 123 Clinton Street be cut down, questioned if Conrad Donovan, the newly elected auditor for Derry Township, was a Derry Borough resident, and questioned the raise given to the Supervisors this year.

There being no further questions the meeting was continued.
