## **Minutes, June 6, 2017 Regular Meeting**

The regular meeting of the Derry Township Board of Supervisors was called to order in the Municipal Building at 5321 Route 982, Derry, PA at 7:00 p.m. and the Pledge of Allegiance was recited..

Patricia Quick spoke on behalf of the tenants of Sundial Village LLC (owned by Robert Brown), whose main concerns are the water, sewage, and new lease agreement; the agreement now includes billing for sewage and excess garbage within the park. Solicitor Nate Boring advised them to contact an attorney.

Joann Lentz addressed issues on Cemetery Way. One such issue involved a vacant house where individuals have been seen entering and occupying the house, as well as speeding on the road and blocked driveways. A discussion was held.

Stephanie Varholak and Nancy Dixon, both of the Brenizer Community Association, requested donations and other assistance from the township regarding purchasing used playground equipment. A discussion was held.
