Minutes, February 3, 2009 Regular Meeting

Announcements: Westmoreland Cleanways (formerly PA Cleanways) has discontinued the recycling program for newspapers, magazines, cardboard, and phone books. This program is being suspended due to the catastrophic downturn of the economy and recycling markets across the world.

The Supervisors are asking the residents to install reflectors on their mailboxes to help the drivers who are plowing the snow and to try to keep cars off the roads as much as possible during snow storms.

Free prescription discount cards are available to county residents without insurance and prescriptions not covered by your current insurance company. The cards will be placed in the lobby of the municipal building for Township residents.
